## GENERAL INFORMATION

Mn X-TREME<sup>®</sup> is specifically formulated for delivery of manganese for all crops.

## DIRECTIONS FOR USE

Foliar Application

Ground: Apply 1-2 quarts of Mn X-TREME<sup>®</sup> in a minimum of 10 gallons of water per acre and repeat as needed.

Aerial: Apply 1-2 pints of Mn X-TREME<sup>®</sup> in a minimum of 5 gallons of water per acre and repeat as needed.

Soil Application

Use 1-3 quarts of Mn X-TREME<sup>®</sup> in a minimum of 10 gallons of water per acre. Not for use with starter fertilizer.

## MIXING AND HANDLING INSTRUCTIONS

Put 1/3 to 2/3 of total required water volume in tank.

Add adjuvants, fertilizers, and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of Mn X-TREME<sup>®</sup> and agitate until thoroughly mixed. Fill tank with remainder of desired water. Check chemical mixture compatibility using a jar test prior to application, especially for high phosphate and alkaline (high pH) solutions. For full strength application, handling or storage equipment MUST consist of either PVCs, polypropylenes, most plastics, or stainless steel. Never use mild steel, nylon, brass, aluminum or copper around, to store, or to handle full strength Mn X-TREME<sup>®</sup>. Rinse handling equipment after use if material is susceptible to corrosion. The use of an adjuvant is recommended. Performing trials with adjuvants may be useful in determining the best inclusion rates for optimal performance. Optimum rate of application will vary depending on soil properties. Information regarding the contents and levels of metals in this product is available online.

## STORAGE AND DISPOSAL

Store in cool, dry place. Store in original container. Keep container tightly closed. Do not reuse empty container. Triple rinse, then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state and federal regulations.
