Above 50 gal / acre: 8 - 16 oz / 100 gal **10 gal - 50 gal / acre:** 16 - 24 oz / 100 gal **Below 10 gal / acre:** 24 - 32 oz / 100 gal

STORAGE AND DISPOSAL
